- Official Practice Day 1:  
Present – Mon. Mar. 5th** U.S. Angler's Choice rules apply during practice. **\*(No Guides)**  
**Closed Fishing Areas:** Inside host marina or take off area and other areas to be defined at the Pre-Tournament meeting
- Official Practice Day 2:  
Tuesday, Mar. 6th** U.S. Angler's Choice rules apply during practice. **\*(No Guides)**
- Official Practice Day 3:  
Wednesday, Mar. 7th** U.S. Angler's Choice rules apply during practice. **\*(No Guides)**  
All boats must be off water by 4 p.m. Mandatory registration held at Scottsboro Civic Center from 5:00-6:45 p.m. **Failure to register on time equals disqualification.** Dinner will coincide with registration and Pre-Tournament meeting to start at 7:00 pm. (Absolutely no Alcohol Permitted)
- First day of competition:  
Thursday, Mar. 8th** Launch site: Goose Pond.  
Blast off beginning at safe light.  
Blast off will be by numerical position with boat # 1 first out, last boat number last boat out.  
Weigh-in start 3:00 P.M. at Goose Pond.
- Final day of competition:  
Friday, Mar. 9th** Launch site: Goose Pond.  
Blast off beginning at safe light.  
Blast off order will be reversed from day one.  
Weigh-in will begin at 2:00 P.M at Goose Pond.  
Awards ceremony will follow closing of scales.
- RESERVE DATE:  
Saturday, Mar. 12th** **(Important)** If weather or other circumstances cause the cancellation of one or more days of competition the reserve date of Saturday will be used. Plan accordingly.

**PARTICIPANT AGREEMENT, RELEASE, AND ACKNOWLEDGMENT OF RISK**

In consideration of Angler's Choice, Inc.'s allowing me to participate in this tournament, I acknowledge and agree as follows:

1. I have read and understand the description of the tournament and the Official Rules of this tournament. I will obey all rules and understand that any violation may result in immediate disqualification without refund of my entry fee. I also understand that tournament officials may reject my application for any reason and in that event will refund my entry fee.

2. I understand and acknowledge that competitive fishing is a dangerous sport, the risks of which include, though not exclusively, drowning, collisions in the water, and injuries from hooks and other fishing paraphernalia. I voluntarily assume responsibility for these risks, identified and not identified, and all risk of injury or death or damage to myself, or my property or to others, including spectators and their property, arising from my participation in the tournament.
